Please complete and sign this affidavit. Present the complete signed Affidavit at embarkation for your cruise and be sure to retain a copy for your records for at least five (5) years. **4. NOT DISEMBARKING IN CUBA**

I hereby certify and attest that I am not disembarking for travel in Cuba.

I acknowledge and understand that U.S. law currently prohibits persons subject to U.S. jurisdiction from traveling to Cuba unless specifically licensed or otherwise authorized under “general licenses” set forth in the Cuban Assets Control Regulations (“CACR”), 31 C.F.R. Part 515, administered by the U.S. Department of Treasury’s Office of Foreign Assets Control (“OFAC”). All travelers, regardless of nationality or U.S. visa status, must comply with the CACR when traveling from the United States on travel with Seabourn Cruise Line Limited (“Operator”). I have reviewed the information regarding restrictions on passenger activities and baggage on sailings to and from Cuba, as set forth on Seabourn’s FAQ page and I understand and agree to these conditions and requirements under U.S. law. I understand that I am required to keep a copy of records establishing my eligibility to travel to Cuba and to bring items back from Cuba, for at least 5 years.

I understand that failure to comply with U.S. law and regulations and all Operator instructions with respect to this Cruise so may result in personal liability under U.S. law, including the CACR, and I absolve Operator from any claims or liabilities. By signing my name at the bottom of this Affidavit, I declare that I fall under the category for licensed travel to Cuba that I have checked above and that I understand and will comply with the foregoing statements and all the applicable regulatory requirements and restrictions related to my travel to Cuba.
